Objectives and Investment Policy

The Fund is actively managed to deliver attractive long-term investment returns (3-5 years) to investors through a combination of income and capital appreciation while limiting the amount of principal risk.

The Fund will invest in a concentrated portfolio of predominantly global corporate bonds that have been identified by the sub-investment manager as being undervalued and therefore offering the potential for price appreciation while also providing on-going income.

The Fund will invest in Investment Grade and High Yield bonds across both Developed and Emerging Markets. High Yield and Emerging Markets bonds are generally riskier than Investment Grade bonds, but may offer higher return potential. While some risk is necessary to produce attractive longer-term investment returns, the investment manager will

make reasonable efforts to control, manage and mitigate this risk. The sub-investment manager may use financial derivatives instruments in the form of forward contracts, options, warrants and credit default swaps primarily for efficient portfolio management and hedging purposes.





Prior to this, from 30 November 2015 to 11 April 2018 the performance relates to the Pentagon High Conviction Bond Fund, a Malta based Alternative Investment Fund. From 28 January 2013 to 30 November 2015, the performance relates to the Value Income Multi-strategy Bond Fund Limited with the status of an exempted company. All data presented in this report for periods prior to 1 May 2018 is unaudited. The full performance history for the Pentagon High Conviction Bond Fund "strategy" relates to the same pool of assets, managed by the same investment team using the same investment approach and investment focus throughout the full performance period outlined. Since 13th April 2022, past performance data reflects the actual performance of the P share class. Prior to 13th April 2022, past performance data shown reflects the Pentagon High Conviction Bond Fund Share Class B US Dollar Accumulating - IE00BF1F4Y06, which has the same fee structure and would be expected to have the same performance as Share Class P US Dollar Distributing – IE000P52VV31. In the circumstances, the past performance data included in this document is believed to be an appropriate reference for investors.
